Sedona is suppose to be a place where people come for quiet nature. We have enough shops! (and sadly, many of those are becoming cheap tourist, t-shirt shops) Let people shop in Phoenix, Uptown and online and lets keep SEDONA NATURAL as it should be..... If they resurrect the amphitheater, size it down to the size of the Santa Fe Opera; 2000 seats will still bring in quality shows. In a perfect world nothing would be built there and only trails would exist.

- 23 I have yet to see any mention of where the water and wastewater services will come from..... What is the plan? knowing water from aquifers is limited, and the current wastewater plant is beyond capacity.
- 25 Restore the Amphitheater, keep open space per original master plan.
- 28 This insistence that the workforce should live in Sedona is unfair to those of us who've worked hard to afford to live here. It is completely normal to commute an hour to work in many areas. Cottonwood is affordable for the workforce. One of the most beautiful areas in the country should not be cheapened because people don't want a pleasant 20-30 minute drive to work.
- 30 Number one priority should be affordable housing for people who live and work here.
- 31 I believe there should be an aggressive amount of investment in apartments and/or rental homes for the workers of our community. With no allowances for STR properties. It's embarrassing to see the amount of tourism dollars that our community receives, only to have policies trotted out that leave middle class and lower income residents with no real housing. Our employees and residents shouldn't be sleeping in and living in their cars...shame on us!
- I was here when we voted on the land swap that allowed the Cultural Park to exist. We were promised it would never be a built-up housing or tourist area. It was to benefit the entire city, while still preserving open space. This is the only reason it was allowed. Honor the promise you made so long ago. Keep it open, keep it for the benefit of the residents who live here, do not turn it into another tourist trap, and do not build it up. We already have more than enough lodging, shops, stores, and restaurants. If homes of any sort are built, people who move in must accept without complaint they'll be sharing that area with everyone.
- 36 A model for use of this property would be Balboa Park in San Diego. If this beautiful piece of property is developed, it will be lost forever. No housing of any kind.

Public transit would provide access to existing stores in W Sedona without replicating them. I envision a neighborhood that isn't so different from the rest of W Sedona except that it promotes community centeredness, walkability, multigenerational, accessible recreation (indoor rec center, pool, community gardens, shaded outdoor spaces and walkways) .
